#### May 1, 2017 Courses Day 1

2015 IBC Means of Egress: (Full Day .6 ICC CEU) This course addresses numerous provisions in the 2015 International Building Code® (IBC®) where the code contains requirements pertaining to establishing a means of egress in buildings. Readers will be presented with specific problems related to means of egress and will be asked to solve each case study. The course is intended to help plan reviewer or building code officials responsible for plan review identify those areas where plan review will include compliance with the IBC. During this training, participants will be listening to lecture and viewing examples, as well as discussing sections of the IBC that pertain to plan review of a commercial building. - •List and describe each of the three parts of a means of egress.
- •Identify the eight fundamental means of egress design issues.
- •Calculate the occupant load and determine the required means of egress capacity.

**2015 IFC Transition from the 2009:**(Full Day .6 ICC CEU)

This interactive training will focus on the key changes presented in the participant material.
